2022-2023 Singer's Contract

I understand that as a singer with Meritage Vocal Arts Ensemble, I am responsible for payment of \$250.00 as annual dues for the 2022-23 musical season. I understand that these dues are necessary to help offset some operating costs for Meritage. I also understand that I am committed to regular, on-time attendance at all rehearsals, weekend workshops, music festivals, dress rehearsals and concerts as scheduled by the Artistic Director, unless the Director excuses my participation. In the event that I am excused from a concert and/or its rehearsals, I understand that my absence does not alter the amount required for annual dues. I understand that I am expected to sell at least two tickets to each performance, as outlined in the Singers Handbook. Furthermore, I agree to abide by all the rules and conditions outlined in the Singers Handbook found on the Members page of the website at Meritage-VocalArts.org.

This contract, signed by each singer, is due on or before September 13, 2022 to Leslie Rudolph, Meritage Membership Secretary, or to Michael Buss, Chorus Manager.

The following are options for payment:

1. **Single payment of \$250, due by October 4, 2022 _____ (initial)**

NOTE: Students currently enrolled in an accredited institution get an automatic 50% scholarship with a printed proof of registration. If the singer opts for a payment plan, each payment will be \$25 on the assigned quarterly dates below. Attach the proof of registration to this application.

2. **Four payments each due as indicated below : _____ (initial)**

- (1) \$70 – due October 4, 2022
- (2) \$60 – due December 6, 2022
- (3) \$60 – due February 7, 2023
- (4) \$60 – due April 4, 2023

3. **Nine monthly payments as indicated below beginning September 6, 2022 _____ (initial)**

- (1) \$50 - due September 6, 2022
- (2) \$25 - 8 payments due 15th of the month through to May 2023

4. **Single donation of \$1000, due October 4, 2022 _____ (initial)**

With this tax deductible option your annual dues are waived, you receive two tickets to all concerts of the season, 2 tickets to our annual fundraising event, donor recognition in the program, and donor ad in the program if desired.

5. **Single donation of \$2500, due October 4, 2022 _____ (initial)**

With this tax deductible option your annual dues are waived, you receive four tickets to all concerts of the season, four tickets to our annual fundraising event, donor recognition in the program, donor ad in the program if desired, and donor recognition by the Artistic Director at a concert of choice.
